This is not a complete list; it may change or vary from time to time. There may be additional care rendered by other independent physicians during your hospitalization. **You are responsible for payment for these services.**

In some cases, your insurance coverage **MAY NOT** completely cover payment for some of the services provided.

- **Check with your insurance company to determine whether a physician’s service will be covered, and to determine what portion of the service you will be responsible for.**

In order for patients to be eligible for insurance benefits, your insurance plan may require you to obtain pre-admission notification and authorization, second opinions for elective surgery, or require action from you to add a newborn to your policy. Compliance with these requirements will result in more complete coverage of your hospital and physician bills and will minimize any balances you may be required to pay.
